If redeemed/switched-out on or before 365 days from the date of allotment – 2%; If redeemed/switched-out after 365 days from the date of allotment – Nil.

The aforesaid changes in load structure shall be applicable for all prospective investments in the scheme effective from May 4, 2015. Investments made prior to May 4, 2015 would continue to attract the load structure which was applicable at the time of investment.
